#### **GENERAL INFO**

The Winter Art Market is held indoors at the Bountiful Davis Art Center, 90 N. Main Street, Bountiful, UT. It will be open Nov 17-Dec. 23, 2024, during normal business hours Tuesdays-Fridays from 10 am-6 pm and Saturdays 10 am-5 pm. We are closed Sundays and Mondays.

Accepted vendors simply need to drop-off their products to the Bountiful Davis Art Center on Nov. 6-11 during business hours. Vendors are not required to stay with their products during the show. All vendors are required to clearly label each product with the artist's (or company's) 3-letter code and price. (Sticker tags or tag labels with a string work well. Your 3-letter code will be emailed to you upon acceptance as a vendor.) All purchases must go through the central check-out at the BDAC front desk. Individual purchases through vendors are not permitted. Artists will receive 65% of all sales and 35% will go to BDAC. There is no booth fee. All vendors will receive a check in the mail with their earnings after the market. Checks will be mailed two weeks after the show.

## ARTIST TREE (Optional)

In place of a booth fee, we kindly ask that all artists create a handmade ornament to hang and sell on Artist Tree that will be displayed at the art center during the Winter Art Market and Gingerbread Festival. Ornaments can be in the form of a mini painting or sculpture, a garland, or something more traditional. Ensure that your ornament has a hook or string loop for hanging. All ornament sales go to support BDAC. Guests typically purchase ornaments priced at \$20 or less.

#### **PRICING**

We recommend selling art at creative products at prices that are appealing and feasible to local visitors. Please keep prices to \$400 or less. For exceptions, please contact Bren Larsen.

### **DISPLAYS and INVENTORY**

All art should arrive ready to display with all necessary hardware. Paintings and 2-D wall art must have D-rings and wire on the back. Small eyelets and sawtooth hangers are not compatible with our hanging system. Artists may bring up to four large 2-D pieces (longer than 16" in any direction) AND up to five small 2-D pieces under (shorter than 16" in any direction). If you are only selling 2-D art (that can be displayed on our gallery hanging system), you do not need to bring a table.

The Bountiful Davis Arts Center has a limited number of display pedestals. If you would like to use pedestals for your 3-D works, please indicate so on your application. BDAC will do our best to accommodate, but please understand that there may not be enough for everyone who expresses interest.

Each vendor is responsible for providing his/her own table (up to 6' long). Please feel free to bring stands, racks, jewelry busts, or other items for displaying your products. If you would like to share a table with another vendor, please make your own arrangements. We cannot accept food products for this market. If you wish to bring extra products to restock your area as you sell, please let us know.

Pick-up is January 2-6, 2024 during BDAC business hours. There will be a \$25 late fee if items are not picked up before the evening of Jan. 6, 2024.
